The meeting was called to order by David R. Brackett, Chairman of the Board of Commissioners, with the Pledge to the flag.

# Superintendent Granger reported on the following:

- 1. Reviewed top residential water use assessment response results with the Board.
- 2. Advised the Board that triannual lead and copper sampling will commence on June 1<sup>st</sup>. Outreach letters will be issued this week.
- 3. Review bids received for Contract No. 2018-03 Permanent Road Patches. DeRosa Paving Inc. was the low bidder in the total unit price amount of \$590.00. The low bidder has successfully provided road patching services to the District. Based on the low bid amount and past performance of the contractor, the Superintendent recommends award to DeRosa Paving Inc.
- 4. Reviewed the bid received for Contract 2018-04 Furnishing Calcium Hypochlorite. Eagle Control Corp submitted the only bid which provides unit pricing in the amount of \$113.40 per 50 pound unit for 2018-2019. This is lower than the current unit pricing. Eagle Control has successfully provided calcium hypochlorite to the District in the past. Based on the bid pricing and performance of the vendor, the Superintendent recommends award to Eagle Control Corp.
- 5. Reviewed the change order proposal for the SCADA upgrade project for control room modifications by Eagle Control Corp.
- 6. Advised the Board that the waste brine pumps for the Hewlett nitrate treatment system failed and that immediate replacement is required to ensure operation of the facility prior to the peak pumping season.

7. The State and Municipal Facilities Program Grant agreement for the restoration of the Beacon Hill Elevated Water Storage Tank Site was received by the District this week.

- 1. Neulist Electrical Upgrade Punch list work has been completed. Final payment can now be issued to the contractor.
- 2. Beacon Hill Tank Replacement Water main connection work was completed yesterday. Electrical work is now underway.
